# The Unlimited Potential of a Helpline Call

Tara\* called Caring Unlimited's 24 hour helpline for the first time after her husband was arrested for assaulting her. In that moment, Tara had no idea what she would do next. Her husband controlled all the resources. He didn't allow her to have a driver's license, forcing her to rely on him for rides to necessary medical appointments. He limited her ability to work and save money and isolated her from friends and family. His family owned the home where they lived and she knew she wouldn't be able to stay there for long. After his arrest, he was released on bail and was ordered to have no contact with her. Despite the order, he continued to contact Tara, making threats and trying to stop her efforts to create a future free from his control.

On the call, the helpline advocate listened compassionately to Tara's experience, answered Tara's questions, and offered options from Caring Unlimited's (CU) resources that could help Tara find safety and freedom. Like many people we serve, Tara was surprised at the range of support available to her and the real difference it would make for her.

Over time, Tara connected with multiple CU programs to put her personal safety plan in place: the **Outreach Program** provided in-depth individualized safety planning, helped Tara arrange safe and reliable transportation to necessary medical appointments, and provided Tara a new phone; the **Legal Program** helped Tara get a Protection from Abuse

Order to fortify her safety; the **Housing Navigator** helped Tara identify housing options and prepare applications for affordable apartments; and **Client Emergency funds** enabled CU to respond flexibly and quickly to Tara's needs including covering the costs of moving to her new, safe apartment.

CU's **support and education groups** connected Tara with a supportive community and reduced her isolation. The weekly online platform enabled Tara to attend regularly while she worked to get her license. Credit-building classes and match savings funds from a community partner enabled Tara to establish a foundation for long-term economic independence—something she had long wanted but seemed out of reach.

Today Tara is settled in her new home, is establishing a career in her chosen field, and has a community of friends surrounding her. The connection she made in her first helpline call created the bridge between being trapped by abuse and the unlimited potential of the life she built for herself.

"I called Caring Unlimited to find a safe place for my daughter and I to stay because we couldn't go home. **What I got from them was so much more** – an advocate who helped me in court, a room in the shelter and then an apartment, a support group to help me with all of the changes, and more. We got to start over."

#### **Executive Director's Message**

Dear Friends,

"What I got from them was so much more."

We often hear this from the people we've helped become safe from domestic violence. Though they hope for something better when they reach out, they do not imagine the range of possibilities that exist for them. The first conversation with an advocates establishes a critical connection. That is why our advocates are specially trained to connect,

understand, and strategize with each caller, just like they did with Tara and Ellen.

This year our staff and volunteers worked alongside almost 2,000 survivors to meet their unique needs, all at no cost and with no time limits on services. Volunteers contributed 2,449 hours of service, ensuring 24/7 access to support, safety planning, and resources through our helpline. You can read more about this life-changing service on page 5.

Our comprehensive array of direct services and access to emergency funding sources gave survivors more options to find safety and the stability to work towards long term goals for economic well-being.

While we are here to help one person, one family, at a time find safety, we also recognize that an individual's experience of domestic violence takes place in a larger cultural context where violence and oppression are allowed to persist. Each caller's experience is both unique and not unique at all. That is why we also work alongside all of you to enact social change to end domestic violence. It has been a joy to return to these activities in person. This year, our education team reached more than 2,000 teens and adults at schools, businesses, other non-profit organizations, and faith communities.

We expanded youth prevention work and collaboration with youth serving agencies thanks to a Youth Dating Violence Prevention grant from the Office of Violence Against Women. As one of just 16 organizations nationwide awarded this grant, we are on the forefront of efforts to engage youth and youth serving adults in the work of ending domestic and dating violence.

We continued our work to be an accessible, trauma informed, and culturally responsive organization. All staff received training on cross-cultural competency, we completed an accessibility audit of our shelter to identify access needs for people with disabilities, and we made substantial updates to our organization's policies to reflect our commitments.

We came back together for our annual Atlantic Plunge, 5K run/walk, and our Community Appreciation reception. I loved talking with you at these events. I heard so many stories of how Caring Unlimited made a difference to you and your friends and family. I drew inspiration from your experiences, ideas, and actions to create a thriving future of unlimited possibilities for all.

I hope you enjoy reading these highlights from our work together over the past year. We have so much to be proud of and so much yet to do!

## **Individual Advocacy**

Individual advocacy in core direct service programs ensures that Caring Unlimited's services comprehensively meet the needs of each client and family we serve.



**4000** nights of emergency shelter were provided to a total of **90** adults and children



**733** individuals received free court advocacy and civil legal assistance



77 individuals participated in ongoing weekly support groups

## Long Term Stability

Programs and resources that support clients in establishing economic independence provide the foundation for long term safety and freedom.



**49** adults and children began new, safe lives in our Transitional Housing apartments



165 clients received a total of \$105,885 in emergency assistance

Prevention education, community outreach, and awareness-raising events create opportunities for action and change the cultural conditions that allow domestic violence to persist.




Over 2,000 students benefitted from prevention education

Caring Unlimited's programs respond rapidly and flexibly to clients' immediate needs. Our impact reflects our commitment to supporting clients' ability to establish economic independence; an outcome proven to have long term positive impacts for individuals and families who are working to free themselves from abuse.

In FY22, COVID's continued impact significantly increased the needs of people we served. We responded creatively and resourcefully. We supplemented our own fundraising with securing COVID related funds, extending the amount of emergency assistance funds available to clients, and having an immediate positive impact on their safety and well-being.

When someone calls the helpline, whether for themselves, or on behalf of someone they care about, they open a door to a whole community of care and resources. The impact of the helpline is long lasting, and as one of the organization's year-round opportunities for volunteering, it is a place where community members, often survivors themselves, find a meaningful way to advocate for change and empower others.
